The aforementioned legal and technical regulations do not contain direct energy efficiency requirements for HEAs. Nevertheless, a drafted technical regulations of the Eurasian Customs Union<sup>2</sup> "On Informing Consumers on Power Efficiency of Electric Power Consuming Devices" is under interstate review. The Customs Union will enforce unified technical regulations (i.e., protocols, technical requirements, and standards) for goods and services manufactured in and/or imported to the territory of EEU member-states. It is planned to apply this Technical Regulations for the following long-term use goods: • electric cooling devices; • washing and combined washing-drying household electric machines (250W, 50Hz); • household dishwashing machines (250W, 50Hz); • electric cabinet ovens (i.e., household electric ovens); • household air conditioners; • household electric lamps.
